Electronic Statement - Consent Form & Disclosure

Thank you for your interest in receiving your future account statements through MyKeptData service available over the Internet. We are pleased to make this service available to you at no additional cost. This service will let you obtain your statement faster, and it avoids the risk that your statement will be lost in the mail or stolen from your mailbox. Please complete and sign this form if you decide you want to receive account statements for all of your accounts through the MyKeptData service.

We will send you an e-mail message to alert you each time that a new statement becomes available for your inspection.

Please provide us with any changes in your e-mail address in the future. You can do this on the MyKeptData site, our Internet Banking site or by contacting us. You may contact us in person or by calling us at 651.232.5600.

You can choose your own 4 to 10 digit password. Your password can be composed of a combination of numbers or letters, or numbers and letters, and it is not case sensitive. Your password cannot contain any special characters such as, punctuation marks, slashes, etc.

Please memorize your password or keep it in a safe place. If, in the future, you believe your PIN is no longer secure, please contact us to arrange for a new password. Your account information will not be shared by the credit union with other companies.

If, after using the MyKeptData service to obtain your statements, you decide you want to return to receiving your statements by mail, simply contact us and request this change.

You will be able to print your statement on the MyKeptData site. This print out will be in the same format and will contain the same information as the statement that you would have received by mail. If for any reason (such as computer failure) you want us to mail you a copy of your statement, simply contact us. There will be a \$5.00 charge for receiving a copy of a statement previously sent by mail or electronic means through MyKeptData.

You can gain access to your MyKeptData statements by using any type of computer that can connect to the Internet. You need to use a browser either Microsoft Internet Explorer version 4.04 or higher or Netscape version 4.0 or higher. You will also need to run an Adobe Acrobat Reader version 4.0 or higher to view your statements. The MyKeptData site includes links to sites from which you can download all of the required software. You will need a printer if you want to create a paper copy of your statements. Periodically, you may receive promotional information from HealthEast Employees Credit Union on its products, services, or interest rates.
